If Panels are in place, the arrangements are as follows:

PANEL A

Disciplinary, Grievance, Redundancy and Capability Panel

This Committee should have 3 or 5 members and should not include the Headteacher.

It is good practice not to include Staff Governors on this Committee.

PANEL B

Disciplinary, Grievance and Capability Appeal Panel

This Committee cannot have fewer Governors than the above Committee and must have different members to the above Committee. The Headteacher should not sit on either Committee as likely to have been involved earlier in the discipline process. It is good practice not to include Staff Governors on this Committee.
